HMRC TAXATION CODES

Recently a number of members have contacted the Secretary with regards to our Pension Provider Keir and not using the correct codes as supplied by HMRC to the individuals.

I do not wish to get into the politics of the matter but it would appear that some members are paying too little tax on their pensions.

Our advice is that you check that your Tax Code on your recent Pension advice is the same as the one supplied to you by HMRC, if it is different you need to contact HMRC and request that they inform Keir of your correct Tax Code.

Sadly it cannot be done any other way

BULK EMAILS

This is a system that has been set up by the Data Controller at NARPO HQ. You may receive an email from donotreply@narpo.org these are genuine emails and are being sent out on a Bulk System using the email address that you have supplied or updated since your enrolment.

There will be a facility to unsubscribe at the foot of each email, but be aware emails may be from your Notts Branch. These emails will be separate to the National Email and will always be signed off by the Branch Secretary.

Due to Data Protection it is unlikely that your branch will be given permission from the centre to keep any databases containing personal information, under the NARPO Data Protection Insurance, therefore it is likely that the bulk email system will be the only way we will be able to communicate with you the members and only members on a day to day basis. The emails from our own system Wordpress will cease in the not too distant future.

The Website will continue to function in its present form with items being placed on the relevant page.

The membership has now been extended to allow Associate Members who do not have to be Retired Police Officers. Associate Members will have to provide a legitimate link to the Police Service before their application can be considered.

GENERAL DATA PROTECTION REGULATIONS (GDPR) 2018

The new GDP Regs come into Force on 25th May 2018 and will now affect NARPO, all members will need to be contacted and our own Policy will become effective, members will have the right to opt out of receiving emails and have the right to view what we hold on record about them.

On joining NARPO members were inform of the old Data Protection, we would like to reassure members that all our computers are encrypted and password protected.

Emails from NARPO to members should always be on BCC and not visible to a third party.

No information about a member is passed to a third party without the express permission of that member.

We are awaiting a policy document from the National Office which all NARPO Branches are expected to sign up to.
