#### Underpaid Womens State Pension

Due to a glitch at DWP many women who are or were on Married Women's State Pension are likely to have been underpaid and many could be due reimbursement, Married women who hit state pension age before April 2016 are a key group who may be owed. This guide explains who may be affected, and how to reclaim.

This webpage gives you all the details of the underpayment and towards the bottom you will find the following paragraph which gives you a link to a calculator which will tell you after answering a few questions whether you are eligible.

If you believe you may have missed out in the first scenario as a married woman, because of the DWP computer error or you didn't know you could claim a boosted pension, you can do a quick initial check to see if you may be owed using an <u>underpaid state pension calculator</u> developed by pensions advisory firm Lane Clark & Peacock. If you do not have access to a computer contact Brian Marshall on 0115 9556563 who has the calculator and will be able to advise, otherwise contact DWP on free phone 0800 7310469. We do know of one members wife who has been accepted as being under paid going back 6 years.

Basically if you were on the low Married Women's State Pension prior to you or your husband reaching 65, whoever was the later, your pension should have been increased to 60% of your husband's basic State Pension, other rules may have applied if you are or were residing outside the United Kingdom.
