6. CHAIRMAN ADDRESS INCLUDING REGIONAL AND NATIONAL

MATTERS

This year we have restricted attendance to our own membership, but thanks do go to Command and Regional colleagues who have supported us through the year.

I personally thank all the committee for their work and support over the last two years we have managed a few zoom meetings and the Executive have kept in contact. John and Brian Marshall have been extremely busy particularly during lockdowns.

Regionally and Nationally, we have not had any in person meetings, but the iPad, laptops or desktops have been well used. Congratulations to Bruce who is now the Regional Chairman, election was by email through the eight branches in the Region.

Personally, my last National Executive meeting was held on 17/18 February and my Regional Colleague, Bob Mabbutt did a quick resume for Branch Secretaries.

There has been a small group looking at NARPO news to try and make advertising more relevant, how we work more closely with other organisations such as staff associations. There is a wish for members to contribute more with letters, humorous stories,

and the like. We have a new media partner who have a firm brief to deal with types of adverts we put in the magazine. Will take a while as current contracts have to run their course.

It has been decided in principle that in future the National website will have a member only section that would be password protected. Final decision on content not yet made.

At Conference 2019 there was a section on discipline and the potential to impact on our members. Potential that historical enquiries could have impact and create welfare issue and need for advice. Agreed on need for guidance, policies plus a training package for Branches and those people likely to be involved. This will be progressed by the Vice President and training coordinator. No doubt liaison with the Police federation.

Talking of Historical enquiries Hillsborough not yet finished, 2 NARPO members will be standing trial on 14 April in Salford with support from their former staff association and local Branches we have agreed to underwrite welfare costs based on the actual costs when we receive them.

We continue to look at possible new headquarters in line with 2019 Conference motion that was remitted. Vice President and I have been tasked by the NEC to progress this matter, but Covid-19 obviously got in the way of physical visits.

Wakefield hope to resume actual training later in the year for Branch committee members.

A lot of the work I have been involved in relates to Later Life Ambitions or trying to sort out widows' pensions where they must make choice on pension or new relationship. There will be a hearing before a High Court Judge on May 7th to consider and determine the defendants (Home Office) application to strike out our claim.

We are hoping that we can have Conference in Llandudno early September again the signs are hopeful, but we wait for the Governments actions. We hope to identify those of our members that receive any National award during the year and if they agree have it included in the NARPO News magazine

Travel Insurance no one seems to want to provide a Policy like the one we have now, TowerGate are looking for a new provider as AXA will not continue after this year. Personally, this year's increase is still quite a few hundred pounds cheaper than I could find elsewhere after including my medical records.

You will all have seen or heard about the protests over Police, Crime, Sentencing and Courts Bill but this is the Bill that also introduces the Policing Covenant which includes the safeguarding of officers mental and physical health and wellbeing we and the Chairman of the Police Federation said that this should be extended to retired officers and their families. We have been pushing this view with the NPCC wellbeing lead and also MP's.

Mental Health Support. Oscar Kilo has for a few years been the online home and brand of the National Police Wellbeing Service working closely with the College of Policing, NPCC and Home Office to deliver the service their website provides open access. Did not see any mention of retired officers.

Police Care UK a Charity for serving and veteran Police Officers, staff, volunteers, and their families want Police Chiefs and health authorities to work together to develop a national strategy that tackles serious mental health issues.

I represent NARPO on a national Age Sector group which meets with AGEUK normally at their London office but again online for the last year. Among the other member groups are Civil Service Pensioners Alliance and National Federation of Occupational Pensioners who also meet with us and Connect on Later Life Ambitions.

Last meeting was 3 March opened by AgeUk Charity Director Caroline Abraham who outlined their campaign and influencing work.

Working with the NHS to help housebound receive vaccinations.

They have repeated some research looking at the effects of lockdown on the elderly. At the beginning those who were better off, lived with others and were online coped better than those with limited resources. The latest research tended to show that even those who had been coping were now struggling. Their report should be available shortly.

They have been focusing on Health and Care white paper and the mental Health Bill. Major worries about many elderly people not wanting to go into Care facilities and the knock-on effect of many homes closing.

They hope that the Comprehensive Spending Review may look at something based upon the Dilnot report which may help with higher bills but will not be a fix to staffing problems or other issues. It will not raise the quality of care or help younger disabled people. They want to persuade Government to go further with help in the care sector.

Labour is considering their position but have apparently moved away from supporting a National Care service. Government still seeking support for a cross party approach.

AgeUk are looking at a more aggressive approach to Ageism, opposing blanket 'do not resuscitate orders.

A lot of activity around over 75's receiving free TV licences, take up of Pension Credit and what the Government response to non-payers will be. Seems Lord Botham is supporting pensioners.

Finally, I wish to place on record my thanks to 3 committee members who for their own reasons are not seeking re-election they are Heidi Duffy, Brian George and Carolann Henderson we wish them all the best for the future and would be happy to welcome them back if they felt able at any time in the future.

Thanks to all of you who have joined us this evening and I now ask John to present his Secretary's and Treasurers report

7. SECRETARIES/TREASURERS REPORT

Firstly, I would like to thank Brian Marshall for all his work over the previous two years, with regards to the Death Circulations of members, as you may be aware the past twelve months have been problematic, with Covid and Lockdown, which has resulted in several things being put on hold. Members being unable to attend Funerals, florists not available for floral tributes, and the use of the NARPO Drape being restricted. So, we set up a Book of Condolence on the Website, which has favorably been received by the members and families He has contacted members spouses who have now become widows/ers making sure the necessary paperwork has been sent out for them to obtain their pensions in quick manner.

Brian has assisted me over the last six months with Secretarial duties due to illness in my family, and for that I thank him, however things are now returning to near normal.

Injury on Duty Reviews, it appears that Nottinghamshire have now stopped the reviews as none have come in in the last 12 months, but we are still able to assist any member who needs our help.

Locally we have tried to function as normal, attending meeting via Zoom or Telephone with the Force Benevolent Fund, The Branch Committee has held meeting via the internet.

The Social Committee are actively looking a Functions for the next twelve months, once lockdown finishes hopefully, we may all be able to get together again, the committee however requests that anyone who has a suggestion as to events to either let me know or members of the Committee know with your suggestions however outlandish they may be.

We hope to run Ladies Day and other regular Social Events later in the year on venues have opened properly. We will be discussing Policy Documents later in the meeting. I will be able to talk on them then, but they can now be found by going to www.nottsnarpo.org/Policy page.

The Chairman has spoken on Regional Issues, but congratulations go to Bruce Cameron who has been elected as Chair of the Region.

Conference last year was cancelled but other matters have been dealt with by the NEC in virtual meetings, hopefully Conference will go ahead this year in September at Llandudno.

Important information has been either posted on the website or circulated by email and newsletter.

I now turn to the Annual accounts which have been previously circulated, as can be seen due to lockdown this year we have made a large surplus, but it is hoped that a lot of this will be used up this year by the Social Committee.

Norman Mees raised a question as to why in this year the Precept had increased by a large amount, the explanation was that 2019 was our Centenary Year and as such National Off ice allowed us to keep 25% of the Precept to fund Centenary Events hence the large amount show as Social Functions.

I report on the accounts of National Association of Retired police Officers for the year ended 31 December 2020 set out on Page 1.
